# George Mason University Board of Visitors 2023 Executive Summary of Interim Activities

Pursuant to Virginia Code § 23.1-1303(B.13), the Board of Visitors of George Mason University provides the following executive summary of its interim activity and work for calendar year 2023.

The Board of Visitors continues to operate in a transparent manner, to the extent required by law, in all Board actions. All meetings were open to the public, and notice was provided pursuant to Virginia Code § 2.2-3707. Business conducted in closed session during any of these meetings was done in compliance with Virginia Code § 2.2-3711. As required by Article IV, Section 8 of the Board's bylaws, the Senior Assistant Attorney General/University Counsel or representative is invited to and attends all meetings of the Board and its Committees.
